The institute aims at maintaining a healthy and congenial academic environment that will protect the new entrants from the menace of ragging. To deal with ragging incidents, anti ragging squads has been established. The details and contact numbers of anti-ragging squads are enclosed herein. Written undertakings from the senior students are also taken that if anyone is found indulging in ragging he/she is likely to be punished appropriately. The punishment may be in the form of expulsion from the campus, suspension from the class or fine with a public apology. There is strict watch on the seniors inside and outside the campus. Hostel authorities are also putting alert.

The arrangement for ‘Introduction’ between senior and junior students is being officially done at the department level, the date and time of which is being informed on separate sheet. No separate so-called ‘introduction’ sessions are allowed in the departments, hostels or outside the institution. Any type of welcome party or meeting must be held in the presence of either HOD, departmental faculty or the warden. There is another requirement mandatory for the Institute. Each student has to submit an Anti Ragging Affidavit which can be directly printed from www.antiragging.in or www.amanmovement.org and following steps need to be followed:

- ❖ Step 1 : Log on to www.antiragging.in OR www.amanmovement.org
- ❖ Step 2 : Fill in the information as desired.
- ❖ Step 3 : On successful completion you will receive affidavit, both for students and parents, through E-mail. Sign the same and submit in the Academic & Examination Section.

New students may lodge complaint against ragging in confidence with hostel wardens/members of the anti-ragging squads/HoD or any senior functionaries of the institute. The contact numbers of wardens are as follows:




Duties & Responsibilities of Anti-Ragging Squads in NIPER:

1. Anti-Ragging Squad will be maintaining vigil, oversight and patrolling functions and shall remain mobile, alert and active during the period of duty.
2. Anti-Ragging Squad will make surprise visit to all hostels at intervals. Any incidence of ragging may be reported to any of the members of the Anti -Ragging Committee.
3. Discreet random surveys to be conducted amongst the freshers during the assigned duty period, for knowing their well being.
4. *Anti -Ragging squads should ensure that none of the above mentioned activities are initiated by any student of the Institute. Acts amounting to Ragging could be :*

- Teasing, Embarrassing and Humiliating;
- Assaulting or Using Force of Criminal Intimidation
- Wrongfully Restraining or Confining or causing Hurt;
- Causing Grievous Hurt, Kidnapping or Rape or committing Unnatural Offence
- Causing Death or Abetting Suicide

Note: Two members of the above committee should visit the hostel daily at regular intervals. All the Squad members during their duty period **MUST** mark their attendance in the register kept for the purpose (with the security guard) and sign it.
